## 2026 Woodlake Tiger Shark Swim Team Overview

### Application & Fees due Friday, May 1, 2026

The Woodlake Tiger Sharks Recreational Swim Team is held annually during the summer for children who want to learn swimming skills. This program represents the Woodlake Tiger Sharks Swim Team. It promotes the sport of swimming and supports the local Woodlake and Tulare County community.

### Eligibility Requirements

- Ages 6 years to 18 years of age.
- Are willing and able to learn and participate in team and group settings.
- 1<sup>st</sup> Year swimmers must take a swimming test, 25 yards. (6 & Under, NO exceptions)
  - Parents must accompany, bring a swimsuit, towel, & sunscreen, and be ready to jump in.

### Parent Information

- Every Home Swim Meet, each family is required to donate 1 item to be sold at the concession stand.
- For Swim Meets, swimmers need to have a team suit or a solid black swimsuit.
- Parent volunteers are crucial at home & away Swim Meets. We can't run our Swim Meets without volunteer help.
- We require each family (Parent, guardian, aunt, uncle, etc.) to volunteer for at least 4 Swim Meets.
  - Volunteer fee will be refunded at the end of the season if obligations are met.
- Hospitality (Drinks & snacks) will be provided while you are volunteering.
  - Parents have the best seats in the house to see your swimmer!
- A signup sheet will be sent out for parents to volunteer.
  - Don't be nervous or worry about volunteering; we will train and help you.

## Woodlake Tiger Shark Swim Team Release of Liability Minor Waiver for 2026 Participation

voluntarily requested starting on this day, \_\_\_\_\_/2026, agree the Woodlake Tiger Sharks Swim Team", hereinafter referred to as **WTS**, to represent and abide by all guidelines and responsibilities asked of me and by child(ren) by the WTS, Woodlake Tiger Sharks Swim Team Committee, Woodlake Highschool Pool, and the City of Woodlake, and agree not to dispute them in a court of law.

My child(ren), being allowed to participate in any WTS-related events and activities, the undersigned acknowledges, appreciates, and agrees that:

1. The risk of injury to my child(ren) from the activities involved in these programs is significant, including potential for permanent disability and or death, and while particular rules, equipment, and personal discipline may reduce the risk, the risk of serious injury does exist.
2. Swimmers and their parents, family, friends, significant others, or representatives, and any other affiliates knowingly and freely assume all such risk, both known and unknown, even if arising from the negligence of the releases, or others, and assume full responsibility for my child(ren) participation; and, I willingly agree to comply with the program's stated and customary terms and conditions for participation. If I observe any unusual significant concern in my child(ren) readiness for participation and/or in the program itself, I will remove my child(ren) from the participation and bring the attention of the nearest official, or a member of the WTD committee, immediately.
3. Swimmers and their parents, family, friends, significant others, or representatives, and any other affiliates hereby release the other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("Releasees"), with respect to any and all injury, disability, death, or loss or damage to person or property incident to my child(ren) involvement or participation in these programs, whether arising from the negligence of the releasees or otherwise, to the fullest extent permitted by law.
4. Swimmers and their parents, family, friends, significant others, or representatives, and any other affiliates hereby indemnify and hold harmless all the above Releasees from any and all liabilities incident to my involvement or participation in these programs, even if arising from their negligence to the fullest extent permitted by law.
5. Swimmers and their parents, family, friends, significant others, or representatives, and any other affiliates agree and are expected to conduct themselves in a courteous and responsible manner while representing the WTS, community of Woodlake, as well as the sport of swimming, at all times even after practices and meets are over, and shall remain free of any questions involving the issue of morality and sportsmanship. Consumption of alcohol, use of illegal drugs, or involvement in any illegal activity will not be tolerated and will be grounds for disqualification from the team, and will be banned from the Woodlake High School Pool, along with any events that pertain to the WTS or its affiliates. Misconduct could also cause ineligibility and loss of all awards earned.
6. 6 and under will be asked to demonstrate they can safely swim 25 yards to participate in the 2026 WTS swim season. The WTS Committee reserves the right to enforce this rule at its discretion.
7. Showing up late and/or not being ready at the start time at any practices or for any event could lead to disqualification.
8. All practices are simply a tool to help swimmers prepare for the meets and are not a guarantee of winning.
9. Practices & Swim Meets are for swimmers only. No one other than you, your child, coaches, and the WTS Committee will be allowed in the pool during these events.
10. The WTS & Woodlake Tiger Shark Swim Team Committee has the right to refuse/ban the participation of anyone in the practices and meets as they feel necessary. This includes all swimmers and their parents, family, friends, significant others, or representatives, and any other affiliates. ALL problems, disputes, or concerns must be brought to the attention of the WTS Committee ONLY. The WTS Committee has a no-nonsense policy! These rules and regulations are designed for your safety and to keep the program running properly and in a timely and professional manner.
11. Harassment of coaches, timers, committee members, or other swimmers by a child(ren), their parents, family, friends, significant others, or representatives, and any other affiliates will result in immediate disqualification and removal/ban from the practice or Swim Meets and any events pertaining to the WTS. If you are being harassed, you must immediately bring it to ONLY the WTS Committee's attention. Problems, disputes, or concerns will stay private.
12. Swimmers, parents, family, friends, significant others, or representatives, and any other affiliates of either party do NOT have permission to collaborate or fraternize about problems, disputes, or concerns with anyone other than the WTS Committee. Gossiping, spreading rumors, and demonstrating overall poor sportsmanship will not be tolerated!

- 13. If your child is not able to attend one of the Swim Meets, it is your responsibility as a parent to make sure that the absentee form for your child is filled out on time so that swim relays can be adjusted as needed.
- 14. All swimmers shall adhere to all rules throughout the WTS swim season and until the end of the Finals in July 2026.

I have carefully read, understand, and agree to adhere to ALL rules and responsibilities set forth by the Woodlake Tiger Sharks Swim Team Committee throughout the 2026 swim season. Failing to abide by these rules may result in the forfeiture of points and awards. The WTS Committee reserves the right to revoke any team points, prizes, or awards if they see fit. The swimmers, parents, family, friends of, significant others, representatives, & all affiliates, as well as legal guardians of swimmers under the age of 18, take full responsibility and will also be held accountable for all rules! By signing this form, I agree to the Guidelines, Waiver of Liability, Release of Liability, and Image Release Form. I will treat them as legal documents & will not challenge these rules or decisions and forfeit all rights in all courts of law.
